RESPONSIBLE OF DATA PROTECTION (DPO)⁴

CATEGORIES OF PERSONAL DATA

Personal data (surname, name, telephone and e-mail address, ticket, cabin number, type and model of the car, plate, cruise, any other note of booking), conferred and conferring by you, and regarding you or third parties and collected by you or other parties, or processed in the conduct of the with the Controller.

The e-mail address shall be used exclusively to confirm the reservation or any notification related to the same.

If it provides personal data of third parties, it must ensure the respect of privacy obligations and, moreover, provides to them this information on behalf of the Controller and to ensure the reception of any possible consent.

PURPOSE OF THE PROCESSING

Processing is carried out for the following purposes: fulfilment of pre-contractual and contractual obligations, following booking parking requests related to Costa Crociere; fulfilment of consequent law and normative contractual obligations; legitimate interest and protection of rights.

LEGAL BASIS OF THE PROCESSING

- I. Processing of personal data is necessary to execute a contract of which the person concerned is part or the execution of pre-contractual measures adopted on request of the same;
- II. Processing is necessary to fulfil legal and normative obligations;
- III. Processing of data is necessary to pursue the legitimate interest to manage security, landmark preservation and processing of their own rights.

POSSIBLE CONSEQUENCES OF FAILURE TO PROVIDE INFORMATION

Communication regarding personal data is mandatory. The non-communication by the person concerned leads to the impossibility to book a parking and to book and make the payment for it, enjoy the pickup service, custody and delivery of the vehicle as requested.

RECIPIENTS

Recipients/categories of recipients of personal data of yours/of any other person concerned are: Costa Crociere⁵, Security Company, designed as Responsible of Processing, Compagnia Unica designed as Responsible of Processing, Company providers of Services/IT Products, designed as Responsible of Processing, Police Force, Judicial Authority, Professional Profiles as Lawyers, for the protection of rights.

TRANSFER

The Controller does not transfer personal data to recipients located in third countries.

DATA STORAGE

The period of personal data storage is the limitation period required by applicable rules, except for requirements arising from Police/Judicial Authority or necessity to protection of rights.

RIGHTS

The person concerned has right, in statutory case, to ask: access to personal data, rectify; cancellation of personal data; portability of personal data; restriction of personal data processing; the execution of opposition to processing. To exercise these rights, the person concerned could address to the above communication details of the Controller.

RIGHT TO LODGE A COMPLAINT

The person concerned has right to lodge a complaint to the competition authority for personal data processing.

AUTOMATED DECISION-MAKING PROCESSING, INCLUDING PROFILING

Automated decision-making processing and/or profiling⁶ are not effectuated.

DIFFERENT PURPOSES

In case the Controller meant to process these data further, for a different purpose from what they have been collected, information about such different purpose and any relevant information must be provided to the person concerned before any other processing.
